## Legal Guidelines for FMCG & Electronics Sellers

### A. FMCG Product Compliance

  - Recycled packaging allowed only if it meets cleanliness standards.

### B. Electronics Product Compliance

Sellers dealing in electronics must comply with:

1. **BIS Certification** (Bureau of Indian Standards):
